BAN has spent months trying to get timely and accurate updates about this project and its effects on our neighborhood. Now, today, we are presented with another unannounced, drastic change to pedestrian and vehicular traffic patterns. We know these changes, when implemented without warning, pose dangers to residents and travelers.

BAN is presently contacting the agencies involved in this project and our elected officials to express our disappointment and, once again, request the promised community liaison to provide updates and advance notice of drastic changes. ***We urge all of our neighbors to do the same.***
